WHO SHOULD ATTEND: School staff, administrators and educators, teacher aides, counselors, and/or other youth-serving professionals representing K-8 and 7 – 12. Curriculum resource guides for each participant will be provided on a cd-rom at the completion of the two-day training. The training is designed to build on the concepts on Day 1 through Day 2. Participation in the entirety of Day 1 is required to participate in Day 2. Must attend the two day training to receive the curriculum resource guides of more than 800 lessons organized by subject area and linked to conflict concepts.

COURSE DESCRIPTION:

Overview: Day 1: Participants will have the opportunity to begin learning and practicing the core skills of conflict management which fall under four main topic areas: 1) Understanding Conflict, 2) Understanding How Emotions Influence Conflict, and 3) Effective Communication Skills and 4) Problem-Solving. We know through the research that the more educators are able to model the skills, the more likely the students will learn and model the skills. They will receive age appropriate lesson plans (more than 1200 to choose from) developed by the Ohio Department of Education and the Ohio Commission on Dispute Resolution and Conflict Management for each core skill set. These lessons can be integrated into their curriculum in order that the students can also learn these important 21st Century Life Skills which are also core skills of Social Emotional Learning. Participants will have the opportunity to begin reflecting on how they might adapt these lessons for their own classrooms and provide students with an opportunity to learn and practice these skills.

Day 2: Participants will have the opportunity to learn and practice proven classroom management, positive discipline and social emotional learning strategies for preventing, intervening, and de-escalating conflicts when they arise in the classroom. Day 1 is required to participate in Day 2 as the better we are at the core conflict management skills, the more effective we will be at applying positive discipline strategies and methods. Participants will be provided with time to consider how they might use these skills to develop their own classroom management plans for the start of the new school year. Related resources will be provided from the Ohio Department of Education and the Ohio Commission on Dispute Resolution and Conflict Management and free resources for effective classroom management accessible on-line will be shared.
