- VI. Committee Reports: The Joint Annual Statement contains a summary of all activities held from March 2020 March 2021.
 - a. Erie County Update A virtual Senior Jumpstart Expo is being held on March 19, 2021 via Zoom. A total of approximately 350 students from Erie & Huron Counties will be participating in this event. The results of the YouScience students assessments are being used to guide the connections with employers and staff. A Teacher Business Boot Camp will be held in August 2021. Teachers are currently applying. Grant funding has been received and 25 teachers will be selected for participation. A meeting of the full BAC committee is being planned for May.
 - b. Huron County Update We are looking forward to Friday's Senior Jumpstart Expo. A large group BAC committee meeting is being planned for May.
 - c. Ottawa County Update The Ottawa County BAC in partnership with NPESC recently was awarded a RemoteEDx grant for Industry Recognized Credentials. More information will be forthcoming
 - d. Sandusky County update A Teacher Manufacturing Boot Camp is scheduled for June 2021. United Way has provided the funding for graduate credit for all participants. Twenty four teachers will be selected for participation.
